Residential Energy Efficient Appliance Rebate Incentive Program

Peabody Municipal Light Plant is pleased to offer a \$50 rebate to residential customers purchasing energy efficient ENERGY STAR refrigerators (compact units not eligible), ENERGY STAR clothes washing machines, ENERGY STAR dishwashers, ENERGY STAR dehumidifiers, ENERGY STAR programmable Thermostats and ENERGY STAR room air conditioners. A \$100 rebate is offered for central air conditioning systems with a **SEER (Seasonal Energy Efficiency Ratio) rating of 14 or higher.**

Advantages of purchasing ENERGY STAR appliances are:

- √ ENERGY STAR appliances have been identified as being significantly more energy efficient than the average comparable models
- √ Potential savings in energy cost of 15-50%
- √ Reduction of global energy consumption and need of additional generation
- √ Decrease in pollution from fossil fuels used to generate electricity

To be eligible for the PMLP Energy Efficient Appliance Rebate:

- √ Customer requesting a rebate must have an active residential account with PMLP
- √ Proof of purchase in the form of a sales receipt dated on or after May 1, 2003, a copy of the Energy Guide label, with the Energy Star logo, from the appliance purchased and a completed PMLP Rebate Application must be submitted in order to be eligible for a rebate
- √ There is a limit of \$100. total rebate per residential account for the 5 year period beginning January 1, 2008. The rebate amount will show as a credit on your electric bill. Please allow 8-10 weeks for processing
- √ If applying for more than one appliance rebate, you must file an application for each appliance
- √ Appliance must be installed in the residence listed as the electric service location on the rebate application and on PMLP records
- √ Appliance being replaced must not continue to be used at said service location.
- √ Appliance **must** be ENERGY STAR. Full size refrigerators (greater than 7.75 cu. Ft.), clothes washers, dishwashers, dehumidifiers, programmable thermostats and room air conditioners are eligible for a \$50.rebate. **Central air conditioning systems with a SEER rating of 14 or higher qualify for a \$100. rebate.**

This rebate offer is subject to the availability of funding and limited to \$100.00 per account for the five year period beginning January 1, 2008. Appliances must be purchased on or after May 1, 2003. To request an application call 978-531-5975.

An application must be obtained in advance of your purchase to guarantee that a rebate is reserved in your name. Funds will be held in your name for a limited time.
Check the upper right hand corner of the application for your expiration date.
